UPM Raflatac is labeling a smarter future beyond fossils by developing innovative and sustainable labeling solutions. As one of the world's leading producers of self-adhesive label materials, it supplies high-quality paper and film label stock for consumer product and industrial labeling through a global network of factories, distribution terminals and sales offices.

Two of the company's three U.S. factories are located in Henderson County. The Mills River factory began operations in 2001, and the Fletcher has been operating since 2011. Locally, UPM Raflatac employs approximately 350 people.

LEADING IN SUSTAINABLE LABELING

Labels are an integral part of sustainable packaging design, and that's why sustainability is at the core of UPM Raflatac's business. From product design to engineering, reducing the use of resources can have a significant impact on the environment. Using less raw material also generates less waste and creates reductions of total consumer packaging. This also means higher efficiency for brand owners.

UPM Raflatac takes a 360-degree life-cycle approach to sustainability, which not only covers the products it manufactures, but how they are sourced, how they are manufactured and end-of-life scenarios. Both North Carolina factories are 100 percent powered by renewable electricity — in fact, the Mills River factory was the first manufacturing facility in the state whose electrical supply is generated entirely by renewable sources through Charlotte-based Duke Energy's NC Renewable Energy Program. The company's RafCycle® by UPM Raflatac service collects used label liner waste and recycles it into new products.

Paper label materials that include up to 30 percent post-consumer waste (PCW) from recycled label materials and other sources. These products are also certified through the Forest Stewardship Council[™] (FSC-C012530), which allows brands to show their commitment to responsible raw materials sourcing.

• PP - C - PCR* Labels

Made from chemically recycled polypropylene plastic (PP) waste, these multipurpose and food-approved label solutions can be used in all of the same applications as standard PP from virgin materials.

• UPM Raflatac Vanish[™] PCR

Ultra-thin recycled polyethylene terephthalate (PET) film face and liner, both constructed with 90 percent PCR from recycled plastic bottles. The clear film solution for a no-label look with the most PCR content on the market.
